REUSABLE LIDS

The District offers free reusable can lids for the collection of cooking oils and grease that could otherwise cause a clog in your sewer pipes. The lids snap onto any of three common sizes of tin cans forming an airtight seal. Fill the can with used oil/grease, then when solidified scrape waste into trash

Proper Disposal of Medications

Do you have outdated or unused medications at home? Flushing them down the toilet might seem convenient, but it poses risks to water quality and the environment. Wastewater treatment plants cannot remove pharmaceuticals, which can lead to contamination that affects wildlife and potentially public health.



Safe Disposal Options

Instead of flushing, use secure medication drop-off programs or participate in the U.S. Drug Enforcement Administration's Take Back events. These initiatives ensure that

unused medications are safely incinerated, protecting your family and the environment. Check for local drop-off locations available year-round for added convenience.

Handling Mercury-Containing Items

If you have a mercury thermometer or other mercury-containing devices at home, they can pose health and environmental hazards if broken. Look for safe disposal options, including mercury thermometer exchange programs that provide a free digital thermometer in return.

Your Role in Protecting the Environment
